During the Regional Planning Commission's review on Jan 13th, 2025 Plan Hamilton was deferred for additional input with areas east of the river (9-Northeast County & 12-White Oak Mountain) requesting that a working committee be formed as a local task force. Regular meetings have been held since January 2025 with a reexamination of residential Place Types and Rural Corridors serving as the primary focus of the committee's work. Some of these improvements were applied across all planning areas as part of a final review to address oversights in terms of grammar and other minor wording corrections.

The adoption of Area Plans under Plan Hamilton is scheduled to resume this spring with updated versions (April 2025) now posted and available. The following list is intended to highlight the most significant changes as the latest versions of the Area Plans are reviewed. Plan Revisions for Area 9 - Northeast County Note: The Area 9 Plan has been substantially revised. The County formed a committee of community members who worked with county leaders to address concerns and build consensus. The draft plan builds off of the public input and work done previously and is a result of the additional collaboration between that committee and area leaders. The draft consensus plan was discussed at a public meeting on April 7, 2025 See chart below for more details.
